**Some International Ripple Effects of
the NESARA Law:**

The Central Banks of Britain, Canada, Japan and all banking systems world wide are expected to announce that their currencies are backed by precious metals (gold, silver, platinum), within four months after NESARA is announced.

Income taxes are expected to be phased out in all countries world wide within two to four years.

Corrupt governments world wide will be replaced/changed to better governments within four years.

Bank debt relief given to people in 140 plus countries within a year after the announcement of NESARA.

World peace within four months and Common Law instituted world wide within four years.

The restoration of Constitutional Law and the adoption of Common Law allows the introduction of free energy devices, advanced and alternative medical therapies, technologies to clean our air, land and water; and much more.

New International Banking Regulations also require banking systems in all countries to give full debt relief. Any country which fails to do this within four months will be prevented by the International Monetary Fund, from transferring funds into or out of, that country.
